# **Swine Rules and Regulations**

#### **Rules & Regulations:**

- All swine must have a tag or series tag.
- Swine will be shown by breed, with a minimum of 5 in the breed. It will be at the judge's discretion if a particular pig does not meet the characteristics of a breed. For any breeds that have less than 5 pigs they will be placed in AOB. Classes of each breed will be broken by weight. Gilts and barrows will show together. All swine must be weighed by the individual exhibitor and the exhibitor is responsible for turning in the weight card to the superintendent. All animals are subject to a 5% weigh back.
- All males must be castrated.
- Show open to youth who are between 7 and 18 years old as of 1/1/2017
- Showmanship Divisions will be: Seniors 14 -18; Intermediates 10-13; Juniors 7-9
- Hogs must be owned & shown by the exhibitor
- Number of head per class 15 or less (approx).
- Showmanship exhibitors max 15 per class (approx).
- To participate in showmanship each exhibitor must enter minimum one hog in the show
- Show is judged as "Prospect Show" & left to the judge's opinion.
- No maximum or minimum weight requirements
- All hogs must be born on or after January 1, 2017.
- Swine must be free of clinical signs of infestations or contagious disease. All swine originating out of state or purchased out of state must follow Kansas State guidelines.
- Any bedding used MUST be removed by the participant prior to leaving the show

# Meat Goat Rules and Regulations

#### Rules & Regulations:

- All goats must have a USDA premise ID tag to show, and must be tagged with a tag.
- Show open to youth who are between 7 and 18 years old as of 1/1/2017.
- All goats must be owned & shown by the exhibitor and verified by ear tag.
- Wethers are suggested to be dehorned. If horns are left, they should be tipped and rounded.
- All animals must be in proper physical condition, be properly identified and free of visual evidence of
  infectious, contagious or parasitic disease at the time of arrival. No health papers are required, however, animals showing evidence of sickness, infections, contagious or parasitic disease will result in
  the animal's rejection for entry. If the animal is bleeding from recent disbudding or tipping the animal
  will be disqualified. The inspector's decision is final.
- Prospect market goats may be either sex and must have milk teeth and be castrated if male.
- Goats can be braced and must be shown with all four feet on the ground. Animals must be shown
  with a chain or collar used only to control the animal. Exhibitor can only briefly touch their animal
  with their body and cannot use the chain/collar to make their animal tense their muscles. Show
  Director has the right to disqualify violators.
- Market Goats will be shown by weight only.
- Showmanship Divisions will be: Seniors 14 -18; Intermediates 10-13; Juniors 7-9
- To participate in showmanship each exhibitor must enter minimum one goat in the show
- Show is judged as "Prospect Shows" & left to the judge's opinion.
- No class for breeding goats.
- Any bedding used MUST be removed by the participant prior to leaving the show

# Leavenworth County Small Livestock Spring Show Sheep Rules and Regulations

#### **Rules & Regulations:**

- All sexually intact market ewes must have a USDA premise ID tag to show, and all sheep must be tagged with a tag.
- Show open to youth who are between 7 and 18 years old as of 1/1/2017.
- Prospect Market lamb show only; all lambs to have wool no longer than .2 inch at show time
- All lambs must be owned & shown by the exhibitor
- Lambs must arrive on the grounds slick sheared
- All animals must be in proper physical condition, be properly identified and free of infectious or contagious diseases. No health papers are required, however, animals showing evidence of sickness, infections, or contagious disease will result in the animal's rejection for entry. The inspector's decision is final.
- Prospect market lambs may be either sex. Lambs must be born on or after January 1, 2017.
- Males must be castrated
- Market lambs will be shown by Black face, White face, Speckle and then by weight.
- Showmanship Divisions will be: Seniors 14-18; Intermediates 10-13; Juniors 7-9
- To participate in showmanship each exhibitor must enter minimum one lamb in the show
- Show is judged as "Prospect Shows" & left to the judge's opinion.
- No minimum or maximum weight
- No class for breeding sheep.
- Any bedding used MUST be removed by the participant prior to leaving the show
